Re : 3 E. K. C.

In reply to your letter of March 14, 1987 we offer the following program for your approval :

1. Dan Examination :

- a. A.N.K.F. will give Dan examinations for up-to 5 DAN on both Kendo and Iai-do.
- b. March 31, 1987 should be O.K. for closing of application.
- c. Dan examination fees are as follows :

D A N	APPLICATION	REGISTRATION
SHO Dan	¥2,000	¥3,000
2 Dan	3,000	4,500
3 Dan	4,500	6,000
4 Dan	6,500	10,000
5 Dan	7,500	15,000

The revenue will be expended, up to its total amount, to underwrite the following expenses that are required for the examinations :

- (1) The venue rent
- (2) Clerical expenses (phone toll, postage stamp, etc.)

- (3) Allowances for examiners, assistants, attendants, etc. (in accordance with A.N.K.F. regulations)
 - (4) Conference expenses
 - (5) Balance, if any will be transferred to the I.K.F. Fund as A.N.K.F. subsidy.
- d. Examination Rules : The examinations will be conducted in accordance with All Nippon Kendo Federation's Dan Examination Rules.
- e. Questions for written test have been prepared and will be announced on the spot.
