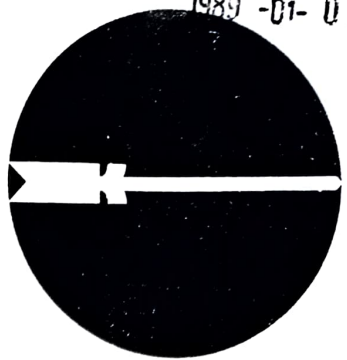

Dear kyudofriends !

I hope the Christmas has been merry.

You were by president Mike Cundy sent a letter dated 12.10.1988 consisting an extract from my letter of 13.09.1988 telling about our arrangements for next years EKF/ZNKR seminar in Finland. Through unfortunat missunderstanding it remained until now unclear if ZNKR would accept our suggestion for the dates. In a letter dated 16.12.1988 president Saito of ZNKR reports that the board of directors on a meeting 6 of december (by the way the day of independence in Finland) agreed to the dates proposed. Since the main items by this are settled we now send the official invitation , some information and the entryforms. The info differs only as to the price from the first.

For the instructors and groupleaders (the A-)seminar was in Paris decided a maximal number of participants for each country: Austria 2, Belgium 6, Finland 6, France 14, Germany, 10, Great Brittain 5, Iceland 3, Italy 6, Netherlands 5, Sweden 1 and Switzerland 8 participants. That makes all together 66 participants.

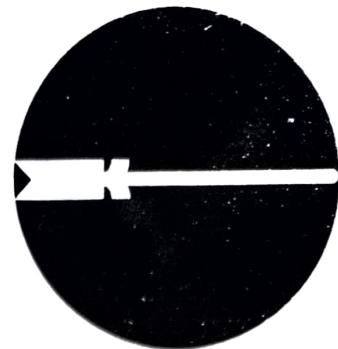
For the B-seminar the the capacity left for us in the sportsschool restricts the number of participants to 100.

The enrollment shall be done on included entryforms (for A-seminar is included as many entryforms as Your country is entiteled to send and for the B-seminar is included only one copy that may be copied as desired) and returned collectively by each countrys official federation to the adress above. The enrollment is registrated when the entryfee of 600 FIM for the A-seminar and 200 for the B-seminar is is paid and together with the entryform is in our possession. Also the entryfee shall be send to our bankaccount collectively.

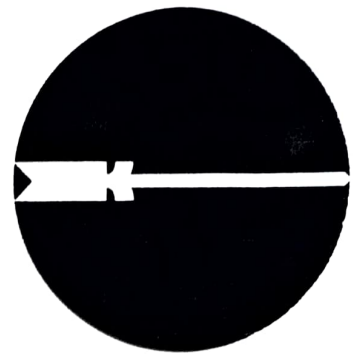

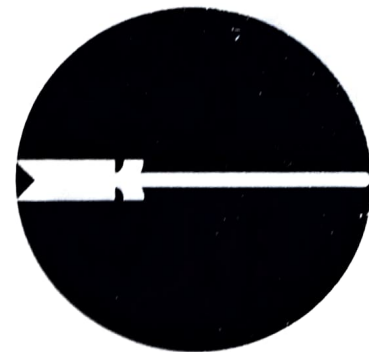
